June Program Speaker: Bobby Bragan

Bobby Bragan was born October 30, 1917, in Birmingham, Alabama. He has been involved with professional baseball for seven decades, beginning in 1937 as a minor league player for Panama City's Class D ball club, earning \$65 a month. He then worked his way through the minor league system to his rookie year in 1940 as the Philadelphia Philly's starting shortstop.

In 1943, Bobby was traded to the Brooklyn Dodgers in exchange for left-handed pitcher Tex Kraus and some cash. While with the Dodgers he played with Jackie Robinson, the first African American major league player. Bobby's statistics include seven years in the major leagues with a career batting average of .240 and a fielding percentage of .950. He batted 1.000 (one of one) in the 1947 World Series against the New York Yankees.

Bobby started the 1948 season with Brooklyn, but the team's general manager, Branch Rickey, wanted to bring up future Hall of Famer Roy Campanella from the minors. Rickey offered Bobby the managerial job with the Fort Worth Cats and he took over in July of '48.

Bobby was player/manager of the Cats from 1948-1952. His teams were always competitive and never finished below the .500 mark. The 1948 and 1949 teams won the regular season title in the Texas League. The '48 club won the league playoffs as well, but lost in the Dixie Series. Bobby's best year as a player with the Cats was in 1949 when he batted .295 to go along with seven home runs and 60 RBI.

He went on to manage in the major leagues a total of seven years as the skipper of the Pittsburgh Pirates, Cleveland Indians, and the Milwaukee and Atlanta Braves. He also spent several years as a major league coach, including stints with the Los Angeles Dodgers and the Houston Colt 45's.

Upon his retirement, Bobby and his family made their permanent home in Fort Worth, Texas.

In 1991, Bobby established the Bobby Bragan Youth Foundation, which awards the promise of a college scholarship to outstanding eighth grade students from across north Texas. To date, the foundation has awarded a total of \$827,500 in scholarships to 331 students, to reward them for their achievements and to give them the incentive to do well in high school and continue on to college.

On May 5, 2004, Honorary Doctorates, degrees of humanities were awarded to Bobby and his wife, Betty, by Texas Wesleyan University, to honor their commitment to the community and the establishment of the Betty and Bobby Bragan Fellowship Hall at TWU.

Bobby set a record as the oldest manager of a professional baseball team on August 16, 2005 when he took to the field to manage the Fort Worth Cats. He was ejected in the third inning when he challenged a call made by the umpire, but the Cats went on to win the game against the Coastal Bend Aviators, 11-10.

The most recent honor Bobby has received is his induction into the Texas Sports Hall of Fame on February 15, 2006. Bobby joined Tim Brown, Augie Garrido, Zina Garrison, Bela and Martha Karolyi, James Segrest, R. C. Slocum, and Emmitt Smith in the class of 2005.

Bobby continues an active schedule, making numerous appearances for civic organizations and businesses, as well as in schools, where he enjoys entertaining and motivating students.

Program: "Thermal Energy Storage"

BIO:

Mark M. MacCracken is the CEO of CALMAC Manufacturing Corporation, whose main products are used for off-peak cooling of buildings using Thermal Energy Storage. In his 25 years with the firm, he has been involved in all aspects of the company including, R&D contracts, patents, manufacturing, marketing and finance. He was the principal investigator on research projects with Oak Ridge National Labs, NASA and National Renewable Energy Research Lab.

Mr. MacCracken's company has been involved in over 3,000 thermal storage systems in 35 countries. He has three U. S. patents, is a licensed Professional Engineer in the state of New Jersey and has written numerous technical articles. He is the former Chair of ASHRAE's Thermal Storage Technical Committee, the current Chair of ARI's Thermal Energy Storage Section, a Board Member of the New York Chapter of the U.S. Green Building Council, and an active member of the International District Energy Association and the Alliance to Save Energy.

LECTURE TOPIC: TES Myths

Thermal Energy Storage, used for Off-Peak Cooling buildings, has a long history around the world. The technology's application in commercial cooling has evolved and improved over the past two decades; however, myths continue to keep it from becoming a staple in energy efficient building design. WESTPORT, Conn.—HVAC&R professionals are most interested in learning more about improving energy efficiency, building automation, and sustainable building technology, according to an online survey by the AHR Expo. According to the *2006 AHR Expo Visitor Survey*, 99% of visitors attended the Show because they felt finding new products was important. Show management will use the survey to gauge the pulse of the industry and to help plan 2007 Show offerings.

RENO, Nev.—A five-year study of Reno and Las Vegas casinos found a direct correlation between exposure to secondhand smoke in the workplace and damage to the employees' DNA. The clinical trial followed 125 employees who work on the gambling floors of casinos. The subjects were nonsmokers who were not exposed to secondhand smoke in their households. The leader of the research team said the DNA damage could lead to a higher risk of heart disease and cancer.

MILWAUKEE—Babies exposed to common household dust may be protected against the development of asthma later in life, according to a study of 810 young children in the Netherlands. Researchers found that those with the greatest exposure to dust in infancy were less likely than others to have chronic wheezing or asthma by age 4. The study lends support to the "hygiene hypothesis" that an excessively clean environment in early childhood may predispose some people to develop asthma. The study is published in the May issue of the *Journal of Allergy and Clinical Immunology*.
