President's Message

Our meeting in September was another great event; Chris VanRite of M&M Manufacturing (right here in town) taught us all about the ASHRAE and Air Distribution Institute research that is being conducted on flexible ductwork. It was gratifying to see first-hand some of the benefits of the money we have raised for research. We had a total of 66 in attendance and continue to remain on track for a record high attendance for the last 10 years.

This month's meeting will be a special treat – Thomas Hartman will be presenting a discussion on relational HVAC control. Mr. Hartman is a world-renowned innovator of control strategies that consume the absolute lowest amount of energy possible. His strategies take advantage of variable-speed technologies (chillers, pumps, cooling tower fans, 2-way valves, etc.) to develop natural optimization curves for the system as a whole.

Our Fall Golf Tournament at Mansfield National Golf Course was a big hit again this year. We had 84 golfers in attendance and when all is said and done we will have raised about \$6,000 for research, putting us well on the way to our goal of \$29,000 for this year.

Last month we also had the privilege of accompanying the North Texas Association of Facility Engineers on their behind-the-scenes tour of Great Wolf Lodge indoor water park. We had a great time meeting the NTAFE folks and it was particularly interesting to learn how air turbines were controlled to generate different patterns in the wave pool.

We continue to make great strides towards the President's Award of Excellence (PAOE). 2,125 points have been gained to date, and we are about 25% of the way to our goal. This is due to the hard work of your chapter officers and committee chairmen.

TOPIC OF DISCUSSION:

Relational Control" HVAC System Control for the 21st Century

The presentation outlines new airflow values derived from research which was co-funded by the Air Distribution Institute, ASHRAE and TXU and conducted at Texas A&M University Energy Systems Laboratory. Guidelines referencing these new values are appearing in ASHRAE Energy Design Guide publications, 2009 ASHRAE Fundamentals Handbook and in revised editions of ACCA Manual D.

BIOGRAPHY:

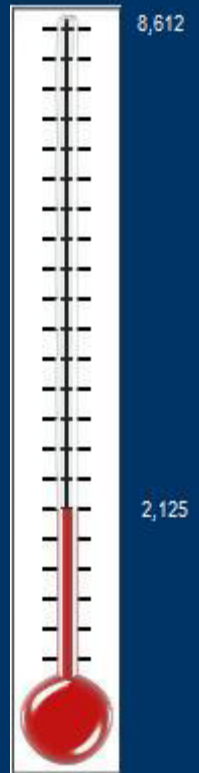
Thomas Hartman is Principal and the founder of The Hartman Company, a technology development and applications firm that works with designers, manufacturers and end users to apply emerging ultra-efficient HVAC and lighting technologies. Among the most notable of Mr. Hartman's developments have been the "Equal Marginal Performance Principle" and relational control concepts. These provide new approaches to integrating variable speed and other new HVAC/Lighting technologies with network controls for simpler, lower cost and better performing building comfort systems.

Tom Hartman holds a number of patents for advanced technologies and works worldwide with manufacturing and engineering partners to develop sound, cost effective products and designs that utilize these technologies for a wide variety of applications. In addition to the development of the Equal Marginal Performance Principle and relational control, Hartman has developed and works to apply a number of other indoor comfort enhancing technologies. Tom currently serves as an editorial advisor to *Heating, Piping and Air Conditioning Magazine* and the on-line publication, *automatedbuildings.com*. Tom is also a member of ASHRAE SSPC 55 and lectures and writes about comfort and energy issues for major symposiums and periodicals all over the world.

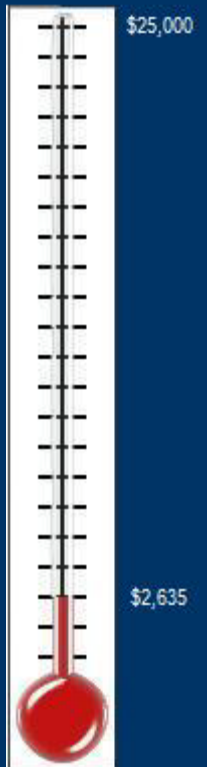
Presentation Outline:

Combining variable speed and digital network technologies provide new and exciting energy efficiency enhancing opportunities with what are called "relational control" techniques. Relational control employs the network capacity of modern DDC systems to operate each HVAC component in accordance with system requirements and in an optimal relationship to the current operation of all other system components. Relational control techniques offer dramatic improvements in energy efficiency, stability and system performance. This new family of control strategies represents a significant change from the stand alone nature of PID control that is still widely employed today. But this newer technology requires new industry process and

practices to achieve success in implementation. So when relational control techniques are applied to achieve ultra-efficient system performance, the process through which it is applied needs to be changed as well to be certain the technologies are adequately supported and end up operating as expected.

There are currently two primary categories of relational control as applied to HVAC systems. Demand based control, which is derived from the Equal Marginal Performance Principle, is employed to optimize the operation of systems that are composed of multiple power consuming components such as central systems. Intelligent iterative control is employed to improve the efficiency and performance of systems that distribute a resource such as heating, cooling or airflow to multiple zones.

This discussion will provide an introduction to these new relational control technologies and outline their advantages over current control practice. It will also discuss the application of these technologies to actual building systems and outline the types of changes in the design / construction / startup processes that are necessary to ensure applications of these newer technologies achieve the projected results.

Program: Energy New Data on Air Flow Performance in Flexible Duct vs Round Sheet Metal Duct

Synopsis:

Chris VanRite gave an excellent discussion on new airflow values derived from research which was co-funded by the Air Distribution Institute, ASHRAE and TXU and conducted at Texas A&M University Energy Systems Laboratory. His discussion included:

- RP 1333 - Final report submitted last month.
- Airflow is important
 - Performance data presented
 - Building loads discussed.
- The Texas A&M University Energy Systems Lab did the work.
- Influenced by EnergyGuide
- The higher the SEER, it does not necessarily lead to more savings, but a better installation does lead to higher energy (cost) savings.
- 70% of installed residential systems were low on airflow
- Duct sealing is insufficient
- ASHRAE Fundamentals and ACCA Manual D are considered the Authority
- Photo discussion of current installations
- Current installations are not efficient
- Air Diffusion Council comments on flexible duct
 - flexibleduct.org - Free PDF download available.
- Reviewed new ductalators.
